Subject:	Homeless in Darlington to benefit from £7,500 award to local charity

Bristol June 2^{nd} 2014: The Deposit Protection Service (DPS), the UK's largest supplier of tenancy deposit protection services, has given £7,500 in the first awards from its Charitable Donations Fund to the 700 Club, based in Darlington.

The 700 Club strives to help homeless people achieve independence in safe, sustainable accommodation. The organisation provides hostel accommodation, offers clients specialised floating support to address the issues that prevent them living independently, administers a Bond Deposit Scheme, and runs a project offering 24/7 emergency accommodation. The charity has a particular expertise in working with those who are most chaotic as a result of drug, alcohol and mental health problems.

John Elliston, CEO of the 700 Club, said "The grant from The DPS will be used to enhance the Bond Deposit Scheme, extending the service it offers to the most chaotic and difficult clients who would usually be excluded from the private rented sector because of their chaotic lifestyles and/or their poor history as tenants. To achieve this, an incentive will be offered to landlords in the form of a significantly higher indemnity against damage and default; and for the client housed, more intense monitoring will be put in place."

Client T, a 36 year old male who had been living rough in a shed for 12 months due to a relationship breakdown said, "The 700 Club has changed my life".

John continues "As a result of this grant, we hope that even those who would, until this money became available, be excluded from the private rented sector, will be able to say the same."

Founded in 1996, the charity facilitated 127 secure tenancies in the private rental sector for excluded people (singles, couples and families) in 2013, and makes a fundamental difference to the community in and around Darlington.

Kevin Firth, Director of The DPS said "It is humbling to see the pain-staking work the 700 Club undertake on a daily basis to improve people's lives. I wish them every success and look forward to hearing about the difference this award will make in the coming months."
